DCPS sends home a bi-weekly progress report that requires a parent signature, a reading-level update once every six weeks, regular communication via social media and the School Messenger communication platform. In addition, all of our teachers have school cell phones, which are primarily used to make and receive calls from families. Additionally, we hold parent events focusing on building relationships between teachers and families, family learning sessions, and literacy and math night. Each quarter, we also schedule appointments for all families to discuss their student's progress to coincide with the release of report cards.

In addition, we provide opportunities to work one-on-one or in group learning sessions with staff who have expertise in a specific area. For example, our KIPP Through College team provides monthly learning sessions about preparing for, going to, and staying in college.
